- 1. <u>PURPOSE</u>. This Work Instruction provides guidance for the oversight for conducting company audits and inspection activities for tank barges enrolled in the D8/D9 Tank Barge Streamlined Inspection Program (TBSIP). Any comments or suggestions for improvement may be sent to District Eight (D08-DG-District-DPI @uscg.mil) or District Nine (D09-DG-District-D9-dpi).
- 2. <u>ACTION</u>. All Ninth District COTPs/OCMIs shall ensure compliance with the requirements outlined in this instruction.
- 3. <u>DIRECTVES AFFECTED</u>. Cancellation of CGD8/9INST 16703, JOINT EIGTH/NINTH DISTRICT INSTRUCTION, renumbered as MMS Work Instruction.
- 4. <u>DISCUSSION</u>. This is the third update to the Guide for the Joint Eighth and Ninth Coast Guard District Tank Barge Streamlined Inspection Program (TBSIP). It gives detailed guidance to both Coast Guard personnel and interested tank barge companies on developing, administering, and oversighting TBSIP (and its TBSIP Select variant). Hereafter, the Guide will only distinguish between TBSIP and TBSIP Select when the distinction is required for clarity; elsewise, the generic term "program" will be used to simplify wording.

This program is a voluntary vessel inspection alternative under 46 CFR Part 8 Subpart E. Company TBSIP Agents and company TBSIP Barge Examiners may not serve as Marine Inspectors. A qualified Coast Guard Marine Inspector shall cyclically attend each barge in this program, inspect it for regulatory compliance, and document those findings in the Coast Guard's MISLE database (Sec. IV, Sec. V).

5. <u>DISCLAIMER</u>. This guidance is not a substitute for applicable legal requirements, nor is it itself a rule. It is intended to provide operational guidance for Coast Guard personnel and is

- not intended to nor does it impose legally-binding requirements on any party outside the Coast Guard.
- 6. ENVIRONMENTAL ASPECT AND IMPACT CONSIDERATIONS. Environmental considerations under the National Environmental Policy Act (NEPA) were examined in the development of this Instruction. This Instruction included preparation of guidance documents that implement, without substantive change, the applicable Command Instruction or other Federal agency regulations, procedures, manuals, and other guidance documents. It is categorically excluded from further NEPA analysis and documentation requirements under Categorical Exclusion (33) as published in COMDITINST M16475.1D, Figure 2-1. An Environmental Checklist and Categorical Exclusion Determination (CED) are not required.

8. PROCEDURE.

a) Audits: The purpose of auditing a TBSIP enrolled company is to verify that the company, its TBSIP support personnel and barges comply with the requirements of the Company Action Plan, Tank barge Action Plan, and the "Guide to the TBSIP 3.0". All audits shall be followed as referenced in the "Guide to the TBSIP 3.0 Section V."

C) MISLE Casework and Sample Narrative Guidelines.

Note = An OCMI will no longer endorse the COI for Annual or Periodic Inspection Activities. Activities are not required in MISLE.

- 1. Certificate of Inspection, Dry-dock, ISE, Damage Survey Procedures, or other Inspection Types where a CG Marine Inspector attends the vessel:
 - a. Vessel Inspection Type. From the pull-down menu in MISLE choose appropriate type.
 - b. Title/Description. This is a free-form block in MISLE. Use the format "TBSIP, X, Company Name {short format}" where X is the Vessel Inspection Type in the MISLE pull-down menu and the Company Name {short format} is drawn from the list provided below.
